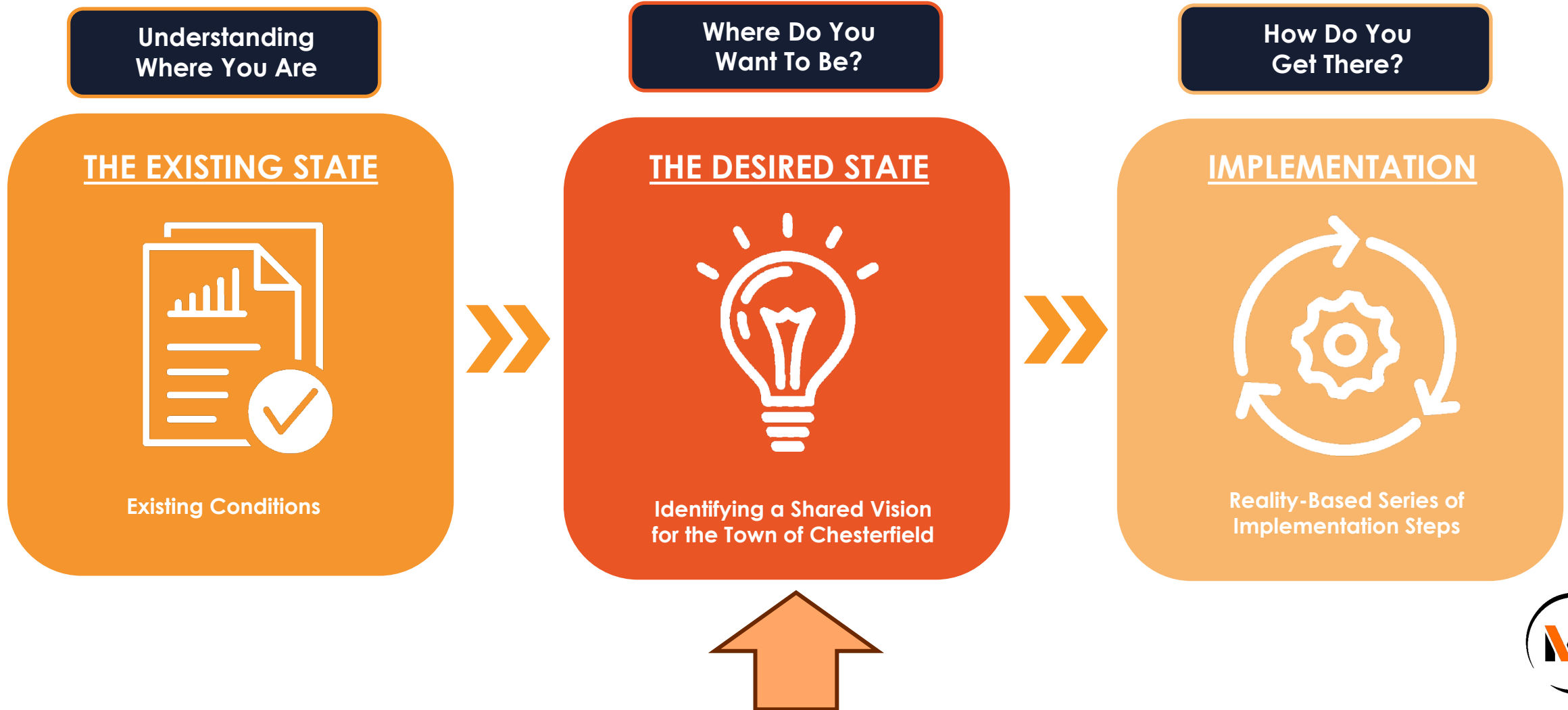

Open House

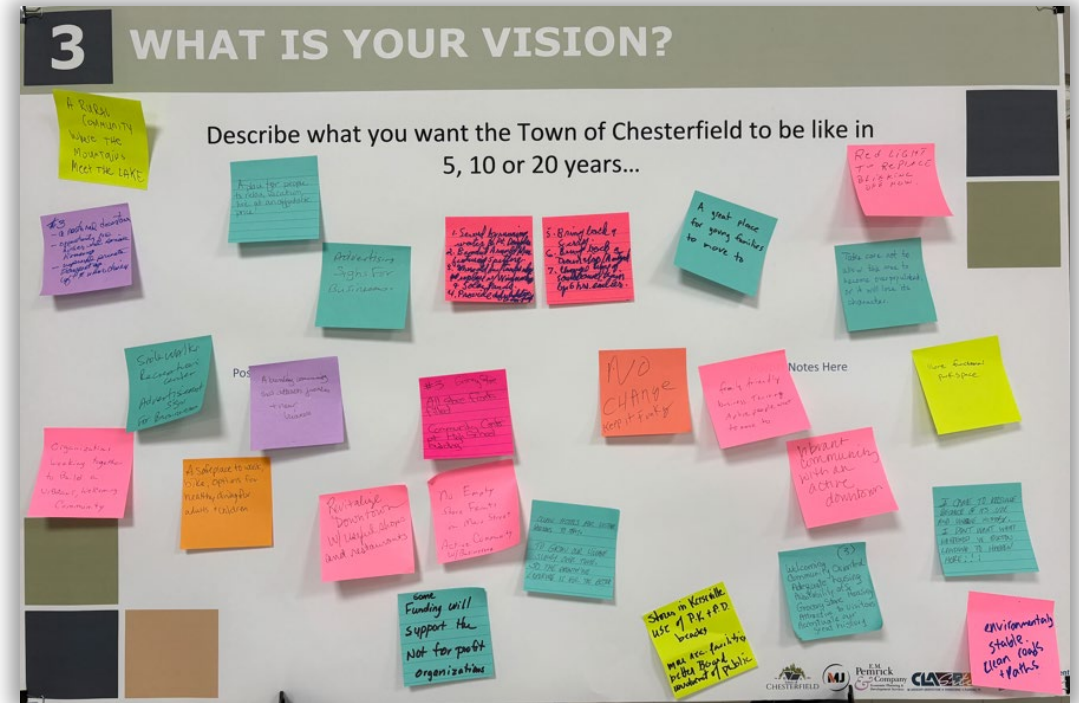
- Tuesday, April 30, 2024, 6:00 – 8:30 PM

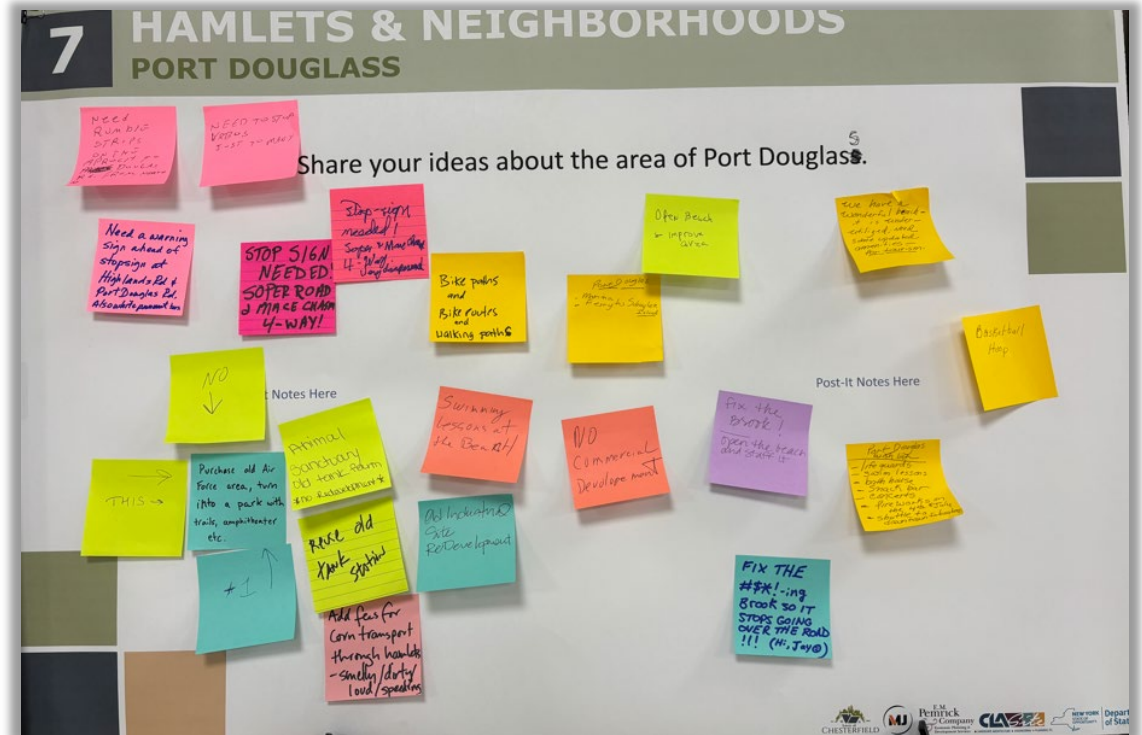

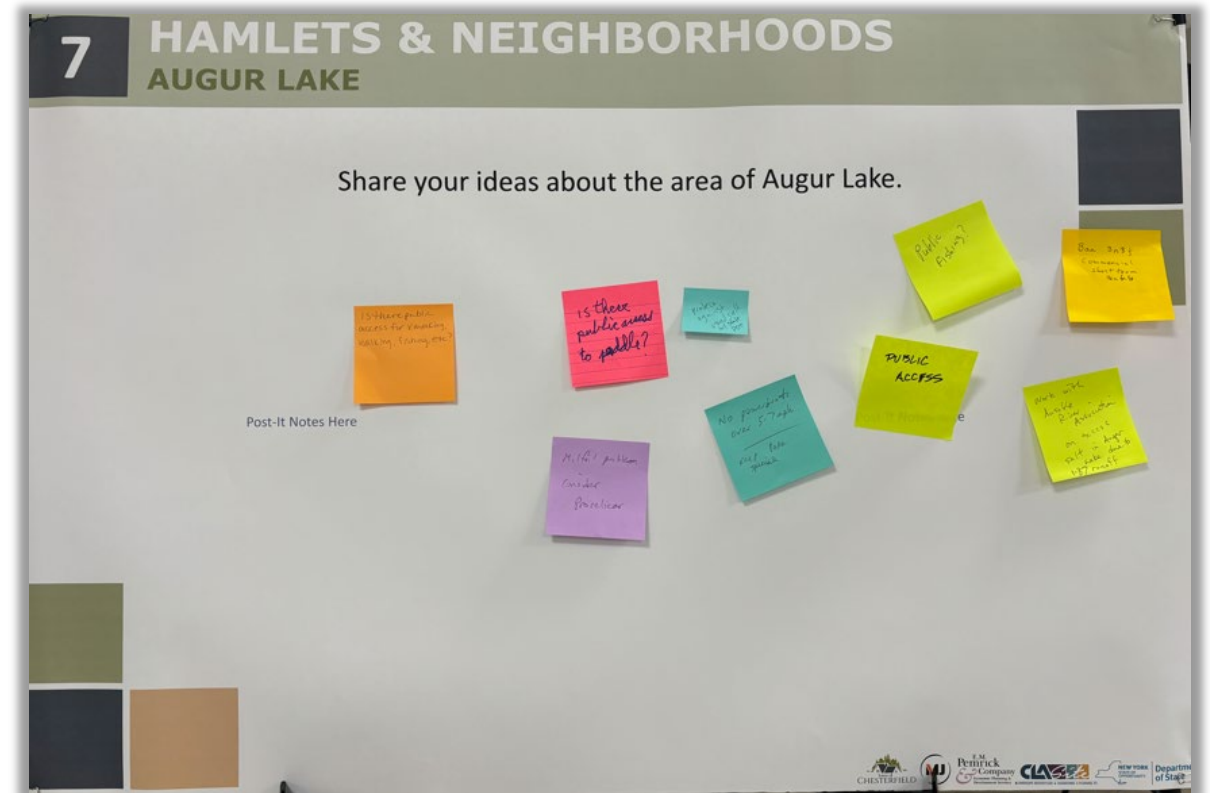

Vision and Goals Exercise

Overview of NYSDOS Smart Growth Principles

- Since 2007, the Environmental Protection Fund (EPF) has contained a line of funding dedicated to supporting smart growth in New York State via a series of competitive grants to municipalities and not-for-profit partner organizations.
- DEC is responsible for distributing a portion of these funds toward smart growth.
- The Department of State (DOS), which has traditionally been responsible for local government planning and development-related assistance, will receive the remainder of these funds for distribution statewide.



Vision and Goals Exercise

Overview of NYSDOS Smart Growth Principles (Cont.)

- The Smart Growth Program offers municipalities the opportunity to plan and zone for their community by addressing all aspects of Smart Growth.
- Smart Growth is an approach to community planning and development that integrates what are known as the “**3 Es**”—**Economy, Equity and Environment**, with an emerging fourth **E—Energy**.
- Smart Growth promotes several land use planning principles that create livable, sustainable and equitable communities.



Vision and Goals Exercise

Overview of NYSDOS Smart Growth Principles (Cont.)

When adopted, the Town's Comprehensive Plan update must address the following general Smart Growth principles, in addition to the elements suggested by the New York State statutes:

1. Promote mixed land uses in focus areas
2. Create an adequate range of housing opportunities and choices
3. Promote development and redevelopment where infrastructure is adequate and sustainable
4. Build on traits that make a distinctive and attractive community with a strong sense of place
5. Promote well-planned and well-placed public spaces
6. Promote sustainable compact neighborhoods
7. Increase mobility and circulation within jurisdictional lines and improve connectivity with areas outside jurisdictional lines
8. Promote sustainable mass transit that reduces the local levels of greenhouse gas emissions
9. Promote walkable/bikeable neighborhood designs
10. Promote and integrate clean energy resources and related incentives
11. Improve green infrastructure and resident's participation to this effort
12. Increase resiliency to extreme weather events
13. Encourage social diversity and integration
14. Expand planning and implementation efforts across jurisdictional lines, to increase effectiveness, sustainability, and resiliency
15. Promote community and stakeholder collaboration in planning

Vision and Goals Exercise

Community Vision – What is a Vision?

- A vision statement establishes the direction of the community over the **next five to ten years**.
- It forms the basis for the **Comprehensive Plan**
- All subsequent **recommendations aim to achieve** the established vision
- Use **present tense** (as if you are 10 years in the future)

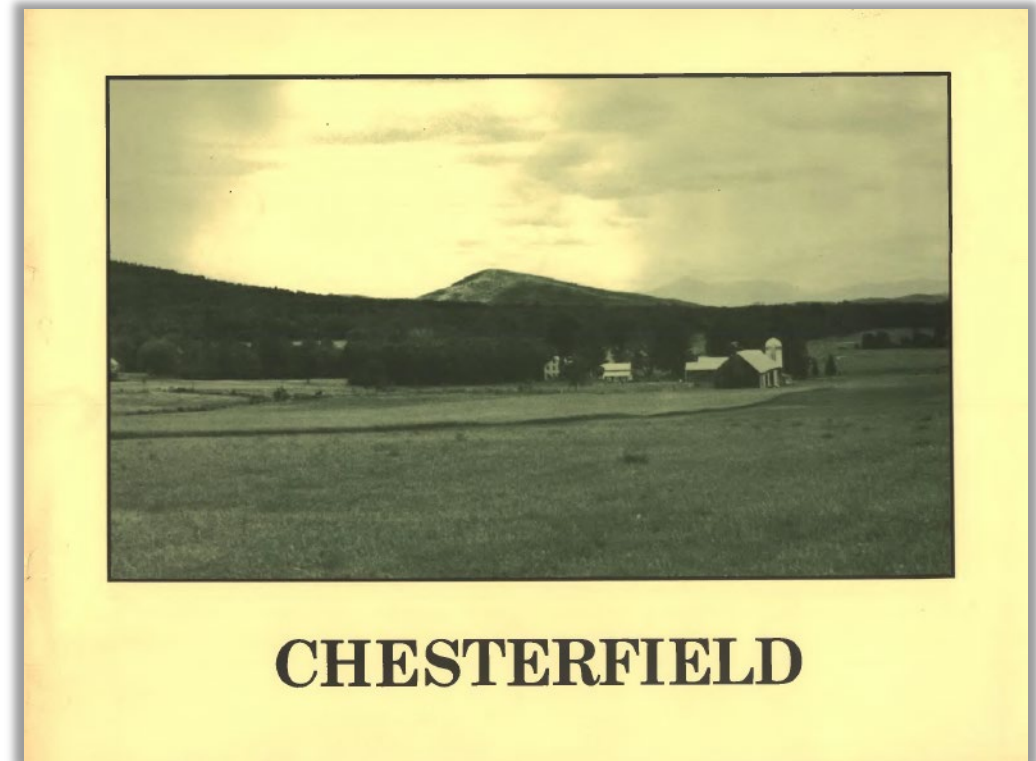

Community Vision – What is a Vision? (Cont.)

- Subjects typically addressed:
 - Common **values** of a community
 - **Qualities, resources or assets** that make a community unique or describe its identity
 - **Attributes** people like and want to be sure **to keep or want to change** about their community
 - **Preferred future** for various subject areas of the community

DRAFT Vision for Discussion

An enhanced built environment complements the welcoming **small-town charm** and supports the momentum of budding **local entrepreneurship** and **agritourism**. Diverse housing types, high quality services, and infrastructure support existing and new residents, families and community members aging in place. An accessible **trail network** links local businesses and **regional recreational destinations** such as the Poke-o-Moonshine, Lake Champlain, Wickham Marsh, Trembleau Mountain and the Ausable River. Chesterfield is a **sustainable** close-knit community of hamlets that offers abundant opportunities for **community** connections, flourishing **businesses**, and unique **recreational experiences**.



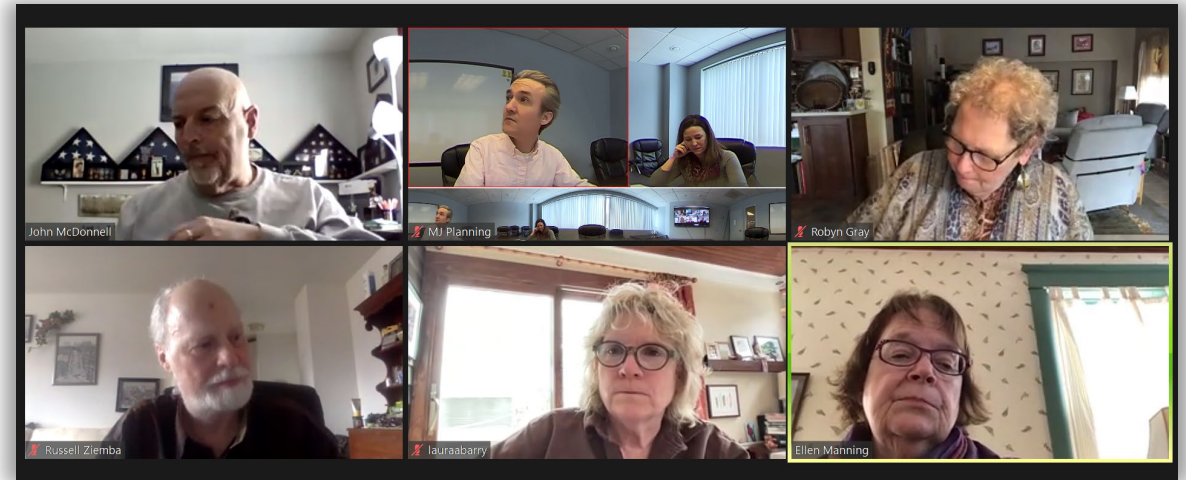
